IMSSA TRAINING PROGRAMMES

ARBITRATION TRAINING (4-DAYS)

This course explains arbitration and teaches participants how to decide whether or not to use it, and how to prepare and present cases at arbitration. This includes:

- assessing the merits of a case;
- taking statements;
- leading witnesses;
- cross examining; and,
- presenting opening and closing arguments.

It also deals with the law as it applies to arbitration.



NEGOTIATION AND DISPUTE RESOLUTION (3-DAYS)

The main emphasis of this course is on **negotiating skills** (1 whole day). It also covers:

- problem-solving;
- mediation skills;
- understanding conflict;
- communication; and,
- conflict management skills.

The course can be run for parties jointly or separately.

JOINT DISPUTE RESOLUTION (2 TO 3-DAYS)

This course provides union and management with an understanding of the options available to them for jointly resolving disputes, as well as providing them with the skills to do so more effectively.

CONFLICT MANAGEMENT AND DISPUTE RESOLUTION: CREATING A CLIMATE OF TOLERANCE (3-days)

This course is similar to the Joint Dispute Resolution course but it also focuses on how to deal with political differences in the workplace. It examines specifically:

- different ways of managing conflict;
- effective communication skills;
- problem-solving and mediation; and,
- ways of preventing, managing and intervening in crisis situations on the shop-floor.
