Since 1985, over 2000 arbitrations concerning industrial relations disputes have been conducted under the auspices of the Independent Mediation Service of South Africa (IMSSA), whose arbitration panel includes many of South Africa's leading labour lawyers and industrial relations practitioners. The IMSSA Arbitration Digest contains a detailed compilation of these awards.

The Digest is designed to serve the needs of all those involved in the arbitration process, including the arbitrators themselves, union officials, industrial relations practitioners and lawyers. It is divided into ten chapters covering -

- the practice and procedure of arbitrations
- the rules of evidence
- · interest disputes
- retrenchment
- · collective bargaining
